**SUMMARY NOTICE OF PENDENCY OF CLASS ACTION
AND HEARING ON PROPOSED SETTLEMENT**

YOU ARE HEREBY NOTIFIED that the Class Representatives and Iomega in the above-captioned Class Action lawsuit have entered into an agreement to settle this Class Action.

PLEASE BE FURTHER ADVISED that pursuant to an Order of the Delaware Superior Court, dated March 21, 2001, a hearing will be held on June 8, 2001 at 10:00 a.m. at the Delaware Superior Court, 1020 N. King Street, Wilmington, Delaware 19801 for the purpose of determining (1) whether the proposed settlement of the Class Action under the terms set out in the Stipulation of Settlement of Class Action on file with the Court, should be approved by the Court as fair, reasonable and adequate; (2) whether the Class Action should be dismissed on the merits and with prejudice as against Iomega pursuant to the terms of the Stipulation; (3) whether the Class as defined in the Stipulation of Settlement of Class Action should be permanently certified; and (4) the reasonableness of the application of the Class Counsel for an award of attorneys' fees and/or reimbursement of costs and expenses incurred in connection with the Class Action.

If you purchased an Iomega Zip® drive between January 1, 1995 and March 19, 2001 your rights, **including claims for damage to your Zip® drive and/or losses from the corruption or loss of data as a result of such damage**, may be affected by the settlement of the Class Action.
