LICENSE AGREEMENT

Please read carefully all the terms and conditions of this License before installing this software. Installing the software indicates your agreement to the following terms and conditions of this License Agreement (the "License"). If you do not agree with the terms and conditions of this License, do not install or use this software.

LICENSE. In consideration of your agreement to this License Iomega®, as sub licensee of Maxtor® Corporation, grants to you a non-exclusive License to use, execute, and display this copy of DataSafe™ Wizard (including all forms of code and related documentation, the software) on one or more computers in a network which includes the DataSafe NAS device. Iomega reserves all rights not expressly granted to you under this License.

OWNERSHIP AND TITLE. You own the physical media on which the software is originally or subsequently recorded, but you shall not obtain any rights, title and ownership of the software recorded on the original disk copy and any subsequent copies of the software, regardless of the form or media in or on which the original and other copies may exist.
